

Forty kilometres off the coast of Tanzania and with its ancient blend of cultures the clove scented islands of Zanzibar remains East Africa's most evocative and romantic destination.

The Zanzibar archipelago includes the main island Unguja (known as Zanzibar) and its sister island Pemba Island.

Steeped in history the island has been ruled over the years by the Omanis, Arabs, Europeans and Africans. Here you can wander through the narrow alleys of Stone Town hardly changed since the Arabs sailed their dhows from Oman to build the old town many centuries ago. While Stone Town is a legendary place, with its historic Zanzibari houses and their intricately carved doors the island is also renowned for its idyllic palm fringed sandy beaches and luxury resorts. Zanzibar is the perfect place to relax after a safari.

Zanzibar Doors

The intricately carved doors of Zanzibar offer a fascinating visual history. Traditionally the wealthier the owner the larger and more elaborately carved would the door to his house. Carved into the doors would be symbolic designs and quotations from the Koran, elements to represent the merchants trade as well as frankincense and date



palms to symbolize wealth. Doors were also studded with brass spikes believed to have originated from the India where palaces had studded doors to prevent them being battered by war elephants. These days artisans continue the tradition of carving the famous Zanzibari doors and on a walking tour through Stone Town you will see many fine examples.

Spice Island

Zanzibar, also known as the Spice Island, is covered in coconut plantations and spice farms and the aroma of exotic spices fills the air as wander through the alleyways of Stone Town. A local Spice Tour will take you to gardens where you will can rare species' of plants and exotic spices growing such as vanilla, nutmeg, and cloves. Please ask for details.
